
**PRIVACY POLICY
MARL COATINGS LIMITED**

BACKGROUND:

Marl Coatings Ltd understands that your privacy is important to you and that you care about how your personal data is used and shared online. We respect and value the privacy of everyone who visits our website, www.marlcoatings.co.uk ("Our Site") and will only collect and use personal data in ways that are described here, and in a manner that is consistent with Our obligations and your rights under the law.

Please read this Privacy Policy carefully and ensure that you understand it. Your acceptance of Our Privacy Policy is deemed to occur upon your first use of Our Site. If you do not accept and agree with this Privacy Policy, you must stop using Our Site immediately.

1. Definitions and Interpretation

In this Policy the following terms shall have the following meanings:

"Account"	means an account required to access and/or use certain areas and features of Our Site;
"Cookie"	means a small text file placed on your computer or device by Our Site when you visit certain parts of Our Site and/or when you use certain features of Our Site. Details of the Cookies used by Our Site are set out in section 13, below;
"Cookie Law"	means the relevant parts of the Privacy and Electronic Communications (EC Directive) Regulations 2003;
"Personal data"	means any and all data that relates to an identifiable person who can be directly or indirectly identified from that data. In this case, it means personal data that you give to Us via Our Site. This definition shall, where applicable, incorporate the definitions provided in the EU Regulation 2016/679 – the General Data Protection Regulation ("GDPR"); and
"We/Us/Our"	means Marl Coatings Ltd, a limited company registered in England under company number 05703412, whose registered address is Unit 7, Weaver Industrial Estate, Blackburne Street, Liverpool, Merseyside, L19 8J and whose main trading address is Unit 7, Weaver Industrial Estate, Blackburne Street, Liverpool, Merseyside, L19 8J.

2. Information About Us

- 2.1 Our Site is owned and operated by Marl Coatings Ltd, a limited company registered in England under company number 05703412, whose registered address is Unit 7, Weaver Industrial Estate, Blackburne Street, Liverpool, Merseyside, L19 8J and whose main trading address is Unit 7, Weaver Industrial Estate, Blackburne Street, Liverpool, Merseyside, L19 8J.
- 2.2 Our VAT number is 884 2297 88.
- 2.3 Our Data Protection Officer is The Company Secretary, and can be contacted by email at admin@marlcoatings.co.uk, by telephone on 0151 427 6447, or by post at Unit 7, Weaver Industrial Estate, Blackburne Street, Liverpool, Merseyside, L19 8J.

- 2.4 We are a data controller and have a registration in place with the Information Commissioner (the regulatory body which deals with data protection compliance issues).

3. What Does This Policy Cover?

This Privacy Policy applies only to your use of Our Site. Our Site may contain links to other websites. Please note that We have no control over how your data is collected, stored, or used by other websites and We advise you to check the privacy policies of any such websites before providing any data to them.

4. Your Rights

- 4.1 As a data subject, you have the following rights under the GDPR, which this Policy and Our use of personal data have been designed to uphold:
- 4.1.1 The right to be informed about Our collection and use of personal data;
 - 4.1.2 The right of access to the personal data We hold about you (see section 12);
 - 4.1.3 The right to rectification if any personal data We hold about you is inaccurate or incomplete (please contact Us using the details in section 14);
 - 4.1.4 The right to be forgotten - i.e. the right to ask Us to delete any personal data We hold about you (We only hold your personal data for a limited time, as explained in section 6 but if you would like Us to delete it sooner, please contact Us using the details in section 14);
 - 4.1.5 The right to restrict (i.e. prevent) the processing of your personal data;
 - 4.1.6 The right to data portability (obtaining a copy of your personal data to re-use with another service or organisation);
 - 4.1.7 The right to object to Us using your personal data for particular purposes; and
 - 4.1.8 Rights with respect to automated decision making and profiling.
- 4.2 If you have any cause for complaint about Our use of your personal data, please contact Us using the details provided in section 14 and We will do Our best to solve the problem for you. If We are unable to help, you also have the right to lodge a complaint with the UK's supervisory authority, the Information Commissioner's Office.
- 4.3 For further information about your rights, please contact the Information Commissioner's Office or your local Citizens Advice Bureau.

5. What Data Do We Collect?

Depending upon your use of Our Site, We may collect some or all of the following personal and non-personal data (please also see section 13 on Our use of Cookies and similar technologies and Our Cookie Policy [here](#)):

- 5.1 name;
- 5.2 business/company name
- 5.3 job title;
- 5.4 profession;

- 5.5 contact information such as email addresses and telephone numbers;
- 5.6 demographic information such as post code;
- 5.7 IP address;
- 5.8 web browser type and version;
- 5.9 operating system;
- 5.10 a list of URLs starting with a referring site, your activity on Our Site, and the site you exit to;

6. How Do We Use Your Data?

- 6.1 All personal data is processed and stored securely, for no longer than is necessary in light of the reason(s) for which it was first collected. We will comply with Our obligations and safeguard your rights under the GDPR at all times. For more details on security see section 7, below.
- 6.2 Our use of your personal data will always have a lawful basis, either because it is necessary for Our performance of a contract with you, because you have consented to Our use of your personal data (e.g. by subscribing to emails), or because it is in Our legitimate interests. Specifically, We may use your data for the following purposes:
 - 6.2.1 Providing and managing your Account;
 - 6.2.2 Providing and managing your access to Our Site;
 - 6.2.3 Supplying Our services to you (please note that We require your personal data in order to enter into a contract with you);
 - 6.2.4 Replying to emails from you;
 - 6.2.5 Supplying you with emails that you have opted into (you may unsubscribe or opt-out at any time by using the links provided in Our emails);
 - 6.2.6 Analysing your use of Our Site and gathering feedback to enable Us to continually improve Our Site and your user experience;
- 6.3 With your permission and/or where permitted by law, We may also use your data for marketing purposes which may include contacting you by email **AND/OR** telephone **AND/OR** post with information, news and offers on Our services. We will not, however, send you any unsolicited marketing or spam and will take all reasonable steps to ensure that We fully protect your rights and comply with Our obligations under the GDPR and the Privacy and Electronic Communications (EC Directive) Regulations 2003.
- 6.4 You have the right to withdraw your consent to Us using your personal data at any time, and to request that We delete it.
- 6.5 We do not keep your personal data for any longer than is necessary in light of the reason(s) for which it was first collected. Data will therefore be retained for the following periods (or its retention will be determined on the following bases):
 - 6.5.1 Affiliate clients and contact information is retained for marketing purposes in our Customer Relationship Management system (CRM). This is because it will have been added to the system via the soft opt-in consent and will have been a legitimate reason for us retaining this data. For example, where an Affiliate client or contact has elected to

receive marketing materials at the point at which we collected their data, this will be retained for 3 years after which we will assess the status of our relationship with that them. For any dormant contacts e.g. where an individual has not clicked on a link in any email or responded to any letters that we may have sent to them, their information will be removed.;

7. How and Where Do We Store Your Data?

7.1 We only keep your personal data for as long as We need to in order to use it as described above in section 6, and/or for as long as We have your permission to keep it.

7.2 Some or all of your data may be stored outside of the European Economic Area (“the EEA”) (The EEA consists of all EU member states, plus Norway, Iceland, and Liechtenstein). You are deemed to accept and agree to this by using Our Site and submitting information to Us. If We do store data outside the EEA, We will take all reasonable steps to ensure that your data is treated as safely and securely as it would be within the UK and under the GDPR including:

7.2.1 Our Data Controller is responsible for co-ordinating the following with other key people in the organisation:

Management and organisational measures

- carrying out information risk assessments from time to time;
- the commissioning and disposing of IT equipment;
- who outside of the organisation (for example, for computer maintenance) is given access to our premises and/or our IT equipment;
- any additional security considerations this will create;
- our business continuity arrangements to identify how we protect and recover any personal data that we hold; and
- periodic checks to ensure that the organisation’s security measures remain appropriate and up to date.

Staff

- implementation of appropriate initial and refresher training to ensure that our staff understand the importance of protecting personal data; and
- that they are familiar with our organisation’s security policy; and
- that they put its security procedures into practice;
- our organisation’s duties under the Data Protection Act and restrictions on the use of personal data;
- the responsibilities of individual staff members for protecting personal data, including the possibility that they may commit criminal offences if they deliberately try to access, or to disclose, information without authority;
- the proper procedures to use to identify callers;
- the dangers of people trying to obtain personal data by deception (for example, by pretending to be the person whom the information is about or by making “phishing” attacks) or by persuading us to alter information when we should not do so; and
- any restrictions our organisation places on the personal use of its computers by staff (to avoid, for example, virus infection or spam).

Physical security

- technical security measures to protect computerised information;
- protection and disposal of old equipment and hard-copy records;
- access to premises, visitor supervision, disposal of paper waste, and keeping portable equipment secure.

Computer security

- taking into account technological developments;
- ensuring that our computer security needs are appropriate to the size and use of our organisation's systems;
- our security measures are appropriate for our business practices and to the nature of the personal data that we hold.

7.3 As shown in 7.2 above, data security is very important to Us, and to protect your data We have taken suitable measures to safeguard and secure data collected through Our Site.

8. Do We Share Your Data?

8.1 Subject to section 8.2, We will not share any of your data with any third parties for any purposes.

8.2 In certain circumstances, We may be legally required to share certain data held by Us, which may include your personal data, for example, where We are involved in legal proceedings, where We are complying with legal obligations, a court order, or a governmental authority.

8.3 We may compile statistics about the use of Our Site including data on traffic, usage patterns, user numbers, sales, and other information. All such data will be anonymised and will not include any personally identifying data, or any anonymised data that can be combined with other data and used to identify you. We may from time to time share such data with third parties such as prospective investors, affiliates and partners. Data will only be shared and used within the bounds of the law.

8.4 In certain circumstances, We may be legally required to share certain data held by Us, which may include your personal data, for example, where We are involved in legal proceedings, where We are complying with legal requirements, a court order, or a governmental authority.

9. What Happens If Our Business Changes Hands?

9.1 We may, from time to time, expand or reduce Our business and this may involve the sale and/or the transfer of control of all or part of Our business. Any personal data that you have provided will, where it is relevant to any part of Our business that is being transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this Privacy Policy, be permitted to use that data only for the same purposes for which it was originally collected by Us.

9.2 In the event that any of your data is to be transferred in such a manner, you will not be contacted in advance and informed of the changes.

10. How Can You Control Your Data?

10.1 In addition to your rights under the GDPR, set out in section 4, when you submit personal data via Our Site, you may be given options to restrict Our use of your data. In particular, We aim to give you strong controls on Our use of your data for direct marketing purposes (including the ability to opt-out of receiving emails from Us which you may do by unsubscribing using the links provided in Our emails and at the point of providing your details).

10.2 You may also wish to sign up to one or more of the preference services operating in the UK: The Telephone Preference Service ("the TPS"), the

Corporate Telephone Preference Service (“the CTPS”), and the Mailing Preference Service (“the MPS”). These may help to prevent you receiving unsolicited marketing. Please note, however, that these services will not prevent you from receiving marketing communications that you have consented to receiving.

11. Your Right to Withhold Information

- 11.1 You may access certain areas of Our Site without providing any data at all. However, to use all features and functions available on Our Site you may be required to submit or allow for the collection of certain data.
- 11.2 You may restrict Our use of Cookies. For more information, see section 13 and Our Cookie Policy [here](#).

12. How Can You Access Your Data?

You have the right to ask for a copy of any of your personal data held by Us (where such data is held). Under the Data Protection Act 1998, We require the payment of a small fee which will not exceed £10. Please contact Us for more details at admin@marlcoatings.co.uk, or using the contact details below in section 14.

13. Our Use of Cookies

- 13.1 Our Site may place and access certain first party Cookies on your computer or device. First party Cookies are those placed directly by Us and are used only by Us. We use Cookies to facilitate and improve your experience of Our Site and to provide and improve Our services. We have carefully chosen these Cookies and have taken steps to ensure that your privacy and personal data is protected and respected at all times.
- 13.2 All Cookies used by and on Our Site are used in accordance with current Cookie Law.
- 13.3 Before Cookies are placed on your computer or device, you will be shown a “We use cookies to ensure that we give you the best experience on our website. If you continue to use this site we will assume that you are happy with it.” requesting your consent to set those Cookies.

By giving your consent to the placing of Cookies you are enabling Us to provide the best possible experience and service to you. You may, if you wish, deny consent to the placing of Cookies; however certain features of Our Site may not function fully or as intended.
- 13.4 Certain features of Our Site depend on Cookies to function. Cookie Law deems these Cookies to be “strictly necessary”. These Cookies are shown below in section 13.5.

Your consent will not be sought to place these Cookies, but it is still important that you are aware of them. You may still block these Cookies by changing your internet browser’s settings as detailed below in section 13.9, but please be aware that Our Site may not work properly if you do so.

We have taken great care to ensure that your privacy is not at risk by allowing them.

- 13.5 The following first party Cookies may be placed on your computer or device:

Website analytics refers to a set of tools used to collect and analyse anonymous usage information, enabling Us to better understand how Our Site are used. This, in turn, enables Us to improve Our Site and the services offered through it. You do not have to allow Us to use these Cookies, however whilst Our use of them does not pose any risk to your privacy or your safe use of Our Site, it does enable Us to continually improve Our Site, making it a better and more useful experience for you.

13.7 The analytics service(s) used by Our Site use Cookies to gather the required information.
